Dear Colleagues,

In order to adapt to the rapid development of China's asset securitization market, the Executive Committee of the China Securitization Forum (the "Forum") has resolved that the Forum will host its Annual Conference at appropriate times after Spring Festival in Beijing. The 2015 Annual Conference adopted "Global Vision and Stable Development" as its theme, regulators, banks, insurance companies, leasing companies, securities companies, fund company subsidiaries, asset management companies, micro-credit companies, guarantee companies, law firms, accounting firms, rating agencies and other participants will share their advice, skills and strategies in the conference.

The Annual Conference 2015 successfully followed the mature project-oriented organizational model learned from similar overseas securitization conferences. The Structured Finance Industry Group (SFIG) supported the Forum's 2015 annual conference and organized an overseas expert delegation to participate in the conference. IMN and X-Wisdom are responsible for the annual conference as the co-organizers in combination with foreign and domestic experience.

SFIG was established with the core mission of supporting a robust and liquid securitization market. As a member-driven organization with over 50 committees and taskforces, SFIG provides a representative and transparent member-driven platform for industry education and advocacy. SFIG boasts more than 270 institutional members (and growing), including investors, issuers, and all other participants in the structured finance industry. Its inaugural conference, ABS Vegas, held this past February, attracted over 6,500 industry participants, making it the largest structured finance conference in the world. Mr. Richard Johns is the Executive Director of SFIG.

The mission of the China Securitization Forum is to promote the healthy development of China's asset securitization markets and encourage innovation in securitization and structured finance techniques. The Forum was established in May 2006 with strong support from relevant regulators, and it was formally restructured in September 2014. The restructured Forum is dedicated to serving as a unified platform for communicating in the area of securitization and structured finance.

The missions of the Forum include:

- (1) Education: Providing educational opportunities to members, law-making bodies, regulatory bodies, and other interested parties regarding securitization, structured finance and related capital markets.
- (2) Consensus building: Building the broadest possible consensus among members regarding legal, regulatory, policy, and other matters affecting or potentially affecting the securitization, structured finance and related capital markets.

(3) Advocacy

Advocating for the securitization and structured finance industries with respect to legal, regulatory, policy, and other matters affecting or potentially affecting the securitization, structured finance and related capital markets.
